KIDS ON TRACK: FAMILY FUN NIGHT PROGRAM INFORMATION AND GUIDELINES

1. All children attending any Kids On Track program must have a registration form signed by the **parent/ legal guardian** the first time they attend. If your child is bringing a visitor, the visiting child must have a registration form signed by their legal parent or guardian. You can download extra forms at www.kidsontrack.org.
2. Bussing is available for Monthly Family Fun Night and is offered on a “**book a bus**” basis only. You must call the KOT General Mailbox (780-481-2942 ext. 1) on the Friday before the Family Fun Night by 9:00 pm and leave your name, phone number and address. The bus volunteer will call you on Saturday to tell you when and where your stop will be. Please have your phone on and available Saturday morning. If we cannot reach you on Saturday, the bus will not pick you up. We suggest a \$2 donation to ride the bus.
3. A FREE meal will be provided at the Family Fun Nights and Family Celebrations. Donations towards the meal are always welcomed at our reception area.
4. Different programs are offered for different age groups after the dinner. Please ensure your child goes to the proper room/activity: Kids Clubhouse (Grades 1-5), Jr. Clubhouse (ages 4-5), Tots Clubhouse (0-3), Shift Youth GT (Grades 6-10), and Parent’s Café.
5. Any child under grade 1 (Jr. Clubhouse and Tots Clubhouse) must be signed in and signed out of their class by their supervising parent. Children grades 1-5 (Clubhouse kids) and grades 6-10 (Shift Youth Clubhouse) will be released to the foyer after the program. Adults are encouraged to join the Parent Café once their kids have been signed into their classes.
6. Please discuss appropriate behavior and the consequences of inappropriate behavior with your child. The following rules are expected to be followed and if not followed will be addressed with progressive consequences including: time outs, loss of tokens or treats, calls home, week’s suspension, or a permanent suspension. Below are the KOT Top 5 Rules that we use in the Clubhouse programs.

Kids On Track Top 5 Rules

- **Keep your hands, feet, eyes, ears, and bellybuttons to yourself– KOT Kids are respectful!**
 - **When a leader is talking, you’re listening– KOT Kids are good listeners!**
 - **Garby goes in the garby can– KOT Kids are green!**
 - **No name calling, booing, or bullying allowed– KOT is a safe place**
 - **Have fun– KOT Kids are awesome!**
7. We encourage all parents to stay for the Parent Café program. If you are not attending the Parent Café, we encourage you to stay in the building. If for some reason you have to leave the building, please make sure we are able to reach you or your emergency contact during program times.
